MDIS Expands Footprint into India



MDIS has entered into a joint-venture with the VELS Institute of Science, Technology and Advanced Studies (VELS) University in Chennai, India. The agreement – inked on 22nd July by Dr R Theyvendran, Secretary-General of MDIS, and Dr Ishari K Ganesh, Founder and Chancellor of VELS University in India – marks the beginning of MDIS’ third overseas campus, the first two being MDIS Tashkent in Uzbekistan and MDIS Malaysia at EduCity Iskandar, Malaysia.

The total investment for the joint venture is expected to be approximately S\$10 million. The first student intake is scheduled for October 2015, and students will be able to pursue a variety of programmes ranging from Diploma to Master Degrees in the fields of business and management. More programmes will be gradually added to encompass the fields of Hospitality, Tourism, Information Technology and Mass Communication from 2016 onwards.

As part of the programme, students will be required to complete their semesters in both Singapore and India campuses. For the time being, MDIS India will operate out of the VELS University premises. Construction for the new campus in Chennai, an estimated 70,000sqft, will begin in July 2016.

Dr R Theyvendran, the Secretary-General of MDIS said, **“Singapore’s education has a stellar reputation not just in the region, but globally. There is demand from students from around the world to pursue programmes with the Singapore brand: something evident from the vast number of countries that students at MDIS in Singapore come from. Our existing two overseas campuses, MDIS Tashkent and MDIS Malaysia, are doing well, and they stand as a good testament to the strength of Singapore’s brand of education. This is why we are taking bold steps and investing in this third overseas campus in India. We hope to fly the Singapore name high in these markets.”**

EXPANDING THE BRAND GLOBALLY

MDIS Tashkent



Uzbekistan Banking Association under a special resolution granted by the President of the Republic of Uzbekistan. With the growing demand, MDIS Tashkent is embarking on plans to expand its Tashkent campus, and sites for expansion are currently being explored.

Since its establishment in 2008, the student population at MDIS Tashkent has grown from just 275 to over 2,200 students today. MDIS Tashkent is MDIS’ first overseas campus and is a joint venture between MDIS and

MDIS Malaysia

MDIS’ second overseas campus, MDIS Malaysia at EduCity Iskandar, is slated to begin operations at its new campus in 2016 when the first phase of construction is completed.

Facilities such as two student hostel blocks, main building, administrative building, a multi-purpose hall and a soccer cum cricket stadium will be ready during this phase and will be able to support up to 2,000 students. MDIS is also planning to expand our portfolio of offerings to include degree programmes in 2016.



MDIS *Receives* S-Class Certification

When MDIS first embarked upon its Student Experience Study in 2013, the main goal was to find out exactly what it was that MDIS' students wanted out of their experience, and to also find out what the Institute can do to meet their expectations. 

Job Hunting Advisory

The co-founder of Apple Inc, Steve Jobs, once advised graduates that the best way to do a great job is to love it. Clichéd as it may sound, Mr Jobs’ advice is still very applicable today; especially in today’s professional and economic climate, where you have students graduating with degrees but no idea what sort of careers await them.

Finding a job you love has never been more important, but it has also never been more difficult. But worry not! We at the MDIS Business Club have gone out and interviewed five working professionals to find out more about their jobs and what it is that they really do on a day-to-day basis.

► Real Estate Associate

Description:

Act as an intermediary between buyers and sellers of real estate of all kinds. Responsibilities include attending to sales enquiries, performing after-sales services, and performing market research.



Requirements:

- Must be a Singaporean/ Singapore PR
- 21 years old & above
- Possess 4 GCE ‘O’ Level passes
- Council for Estate Agent (CEA) License
- Car for commuting & meeting clients
- Starting Salary: Commission based; agents earned an average of S\$12,767/month in 2014, but the top 5% of agents (known as “super agents”) have been known to earn more than S\$100,000 per month.

The following is from a Real Estate Associate in one of Singapore’s largest real-estate brokerages:

“I’ve always enjoyed both viewing houses and interacting with people from all walks of life ever since I was young, so being a Real Estate Associate seemed like a natural fit for me. I knew that the job was going to be challenging and competitive, but I’ve always been someone who thrived on challenge.

“My daily work day starts with me reading the daily papers and updating myself on new listings within my specialised

Geographical Targeted Area, or GTA. Being familiar with current affairs and policy changes is also very important as they often greatly influence a client’s plans and decisions, and keeping myself up-to-date on such matters is often invaluable.

“My work can be thought of as a cycle of prospecting, arranging appointments, arranging for listing presentations, sales, negotiations, closing and after-sales follow-up. Each step is vital, and if you have good communication and interpersonal skills, you will gradually build up a large potential client base. The ability and willingness to work during weekends and public holidays is also crucial if one wants to be successful in this field.

“As your income is mainly commission-based, there is always the chance that you may not earn enough to maintain your lifestyle during a recession. Of course, this is balanced by the fact that you will likely earn enough to make up for those lean periods during property booms, but if you do not have the stomach for a volatile source of income, you should probably not enter this field.



“Although many people think that Real-Estate Associates have a lot of freedom, the reality is far from that. Between the research, market analysis, behind-the-scene preparations and the maintenance of client relationships, you will probably not end up with a lot of free time to yourself. However, if you’re a disciplined, self-motivated and positive individual with an appetite for risk, this can be a great job for you. For me, I love my job so much that it doesn’t even feel like a job at all!



Auditor

Description:

Collect and analyse data on a company to detect fraud, deficient controls, breaches of regulation and overall failure to comply with management policy.

Requirements:

- 21 years old & above
- At least 3 years of audit experience
- Degree or professional qualification recognised by the Institute of Singapore Chartered Accounts (ISCA)
- Starting Salary: S\$3,000 - S\$4,000 per month

The following is from an Auditor working in one of Singapore’s leading audit firms:

“Although I had wanted to specialise in Taxation originally, in my final year of my Bachelor’s Degree in Accountancy, a couple of international accounting firms came by my school to interview the students. It was then that I learnt about auditing, and after interning at one such accounting firm, I grew increasingly interested in the field.

“An auditor will be exposed to a wide variety of businesses and industries ranging from banking and finance to trading, property development, investment management and so on. With such a varied job scope, auditors must be familiar with all styles and types of accounting and taxation practices.

“A typical work day for me may begin with me training, coaching, managing and mentoring staff. I may also be required to review work performed by some of my other colleagues, and may have to communicate and advise clients, regulators, associates and other service providers. Whatever free time I may have will usually be spent on keeping myself updated on the latest commercial, legal and accountancy news and changes: information which I will, in turn, have to pass on to my clients through the creation of reports and advisory material.



“The thing I love most about my job is the feeling of job satisfaction I get at the end of the day. Through auditing, I am able to provide my clients with a value-added solution to issues, and I enjoy being able to use my skills to identify and solve potential problems before they grow out of control.

“For fresh graduates considering a career in auditing, the most important thing you must have is a goal for your life. That goal can be almost anything, but once you have identified that goal, you can then take the necessary steps towards achieving said goal.”



Human Resource Executive/Manager

Description:

Work with various department managers in the implementation of policies and procedures. HR Executives and Managers are also expected to promote equality and diversity within the organisation, and are sometimes called upon to advise upon policy changes.

Requirements:

- 21 years old & above
- Minimum 2 years of work experience
- Strong Communication and Interpersonal skills
- Proficient in MS Office and SAP
- Degree/Diploma in Human Resource Management/ Business Studies or equivalent
- Starting Salary: S\$5,000 to S\$8,500 per month

The following is from a Vice-President of Human Resources:

“I’ve been in Human Resources (HR) all my life, starting from when I did my Master’s Degree a long while back in Personnel Management. I’ve stayed so long in this field because I’ve always felt that HR was the best area where I could pursue a career in management while still being actively responsible for people and policies.

“Although I work and operate out of Singapore, I am currently responsible for the company’s HR

needs across the globe. As such, I often receive a large number of emails every day, often at odd hours when I am not at work, and must spend most of morning dealing with my email inbox. There are breaks in between, of course, such as when I need to have a meeting with a business leader or my team, but just staying on top of my email inbox can sometimes take up my entire work day.

“Take for instance the time when I was transferred to China for three years and tasked with growing our company’s market share in the world’s largest mobile device market. Together with the Business Head and a few key colleagues, after two years of dedication and hard work, we managed to double our market share and make the company a leader in the Chinese market.

“HR is definitely not for everyone. If you do not have a strong desire to help people become the best they can be; if you are unable to deliver business results in an increasingly competitive, volatile and unstable environment; if you do not have a good understanding of human psychology, law and economics; then HR is not for you. But if you do? Welcome aboard.”

► Knowledge Services Manager

Description:

Manage the operations and activities of a company’s knowledge needs. A Knowledge Services Manager may also be required to manage the budget for the company’s library, develop standards for collection development and cost recoveries, and oversee the company’s general knowledge collection and acquisition policies.



Requirements:

- Advanced degree (JD, MBA, MLIS) preferred
- At least three years of experience in database and web technology
- At least three years of supervisory experience
- At least three years of experience in library contract and vendor management
- Starting Salary: S\$3,000 - S\$4,000 per month

The following is from a Knowledge Services Manager working in Singapore:

“As a graduate of Management Studies, I began my career by first working as a researcher before joining a consulting firm as an industry analyst. I later moved into the field of people management, where I began specialising in knowledge services.

“In my current position, I manage a team of approximately 20 industry experts responsible for collecting knowledge and information on ASEAN. Additionally, I am also responsible for the budgeting and overall business development of my team.

“The actual work I do varies greatly from day to day. On some days, I might be tasked with urgently delivering a vital piece of information to the firm’s consultants out in the field. On some other days, I might be asked to conduct extensive research to be used to inform policy and other long-term corporate decisions. The job scope varies widely, and you never really know what might be waiting for you tomorrow.

“The main difference between information and knowledge lies in application: the former is simple data that is oftentimes meaningless and useless, whereas the latter is material that is instantly actionable and useful. A good Knowledge

Services Manager must therefore not only be a researcher capable of searching out the desired information, but also an excellent communicator who can package and deliver the information in a way that allows it to be immediately useful.

“Fresh graduates considering a career in Knowledge Services must be passionate about learning and interested in becoming an expert in a particular field. If you have no interest or love for news, current affairs and generally keeping yourself up-to-date on advances in your chosen field, this job is definitely not for you. If you have the passion, though, Knowledge Services can be a most rewarding and fulfilling career.”

Personal Banker ◀

Description:

Act as a financial advisor for clients whilst managing their financial portfolio and ensuring that everything complies with banking regulations and internal policies. A good Personal Banker must understand his/her clients’ needs and provide them with the necessary information and advice to make informed decisions about their financial health.

Requirements:

- Singaporean/Singapore PR
- A degree/ diploma in any discipline from a recognized tertiary institution
- Flexible working hours
- Enjoy building relationships
- Have an up-to-date understanding of the financial market
- Able to cope with pressures and setbacks
- Starting Salary: S\$2,700 per month before commissions, but a young Personal Banker can potentially earn up to S\$80,000 per month by consistently hitting his/her sales targets.

The following is from a Personal Banker in one of Singapore's most reputable banks:

"As a veteran in the financial industry for almost 30 years, my dad was more or less responsible for me joining the banking sector. He had always highlighted the importance of saving and creating wealth for others, and I think he always dreamt of me following in his footsteps.

"As a banker, most of my time is spent serving customer enquiries, reviewing their financial portfolios, and following up on their requests. I also spend a significant portion of my day keeping myself up-to-date on the latest global issues and researching on how these issues may impact my clients' portfolios, that I may be better able to advise my customers on the steps they can take to improve their financial health.

"I feel that fully understanding your clients' needs is perhaps the most important thing about being a personal banker. Even when the market is not performing well, as long as you have established a good relationship with your clients, they will stick

with you through thick and thin. Some customers can of course be very demanding, and there are certainly days in which I feel utterly demoralised; but, just like economic downturns and bearish markets, these things too shall pass.

"This career path is a very challenging one, especially at the onset, when you have not yet established a strong network of contacts and clients. However, if you feel that you are a good communicator, have a good understanding of the economy, and thrive under pressure, then this job may just be the job for you."



Preparing for a job interview:

Do research on the company and job opportunity.

Instead of sending out "one-size-fits-all" resumes and mass-sending it to companies, you should always tailor your resume to each job opening you are applying to.



Prepare model answers to standard interview questions.

We're not exactly asking you to memorise your responses, but you should at the very least be prepared for some of the more common questions – such as "tell me about a time where you resolved a conflict with your interpersonal skills" – so that you will be able to respond in a calm and confident manner.

Dress to kill.

You'll never get a second chance to make a first impression, so make sure that your first impression counts! From the moment you walk into a room, your attire is the first thing anybody will notice about you, so make sure it is appropriate and professional.

Be at the right place at the right time.

Short of a natural disaster, there is absolutely no excuse for being late to an interview. If you're not familiar with where the company may be conducting the interview, take a day off to travel to the location and plan your route ahead. If possible, try to arrive at least 15 minutes early so you'll have some time to relax and get used to the environment.



Smile!

Remember that, just like you, your interviewers are only human. A smile will not only put them more at ease, it will also slowly relax you and make you appear that much more approachable.



Nature's Explorer: Pulau Ubin



On 27th June, 30 MDIS students visited the lush island of Pulau Ubin to explore the greener side of Singapore. Located about fifteen minutes from the mainland, the island – whose name means “Granite Island” – is home to just 38 people today and is one of the last places in Singapore that has been preserved from urban development.

Accompanied by staff from the Membership Department, the students took a walk through the Chek Jawa wetlands reserve. Unique to the region and quite possibly the world, six habitats and ecosystems come together in Chek Jawa: sandy beach, rocky beach, seagrass lagoon, coral rubble, mangroves and coastal forest. The reserve is specially protected as it is home to several threatened bird species, and the students were able to observe the many visiting and resident birds.

“The trip gave me a look at a very different side of Singapore,” said Aldeno, a Biotechnology student. “After this trip, I now know of another fun place that I can visit when I’m not studying!”

MDIS to open third overseas campus

in a bid to expand its presence in the region. Management Development Institute of Singapore (MDIS) is setting up its third overseas campus in Chennai, India, in a joint venture with Vels Institute of Science, Technology and Advanced Studies (VELS).

The agreement was inked on Wednesday by MDIS secretary general A Theyyatharan and VELS University founder and chancellor Lakshmi Ganesh.

Founded in 1956, MDIS is Singapore's oldest not-for-profit professional institute for lifelong learning. Its courses are offered in collaboration with several universities from Australia, France, the United King-

dom and the United States. It previously opened its first overseas campus in Tashkent, Uzbekistan in 2008, and its second in Johor, Malaysia. MDIS Malaysia made MDIS the first private tertiary institution to register to ferry into Malaysia.

MDIS will hold a 51 per cent share in MDIS VELS Education Private Ltd, with the remainder held by VELS University. The total investment in the joint venture is expected to be \$310 million.

The overseas campus will have its first intake in October, with about 100 students expected to be admitted. Programmes offered include a diploma and masters in the field of business and management, with more programmes being planned for later in 2016, including hospitality and IT.

Some students may also be required to complete their semesters in both the Singapore and India campuses.

Construction of the new campus in Chennai covering an estimated 70,000 square feet is scheduled to begin in July 2016, after which the university will be able to support 1,500 to 2,000 students. Meanwhile, MDIS India will operate out of the VELS University premises.

Said Dr Theyyatharan, "There is demand from students from around the world to pursue programmes with the Singapore brand, evident from the vast number of countries that students at MDIS in Singapore come from."

"Our existing two overseas campuses are doing well, and that is a fur-

ther testament of the Singapore brand. This is the reason why we are taking bold steps and investing in this third overseas campus in India."

MDIS's second overseas campus, MDIS Malaysia, is slated to begin operations on its new campus after the completion of its first phase of construction in 2016. The new campus will be able to support up to 2,000 students.

MDIS Tashkent, MDIS's first overseas campus, is embarking on plans to expand its premises to meet growing demand. The student population has grown from 275 to 2,200 students since its opening in 2008.

Locally, MDIS Singapore - which was gazetted the Singapore Service Class under the Singapore Service

Class under the Singapore Service Class - will continue to expand. It recently launched three new engineering programmes from Northumbria University earlier this year, in acknowledgement of the demand for engineering courses here.

MDIS is also looking to expand fur-

ther into the region in Sri Lanka, in an accord with Wellesley, having previously purchased a plot of land there. However, Dr Theyyatharan emphasised the intention to focus on establishing its existing overseas campuses first.

Growing up in India, Mrs Thahera Manzur stopped schooling at 17 and left the country to see the world with her seafaring husband. "I got married early and became a housewife," said Mrs Manzur. They settled down in Singapore in 1977, when she was 24, after they had spent two years at sea. She stayed home, taking care of her only daughter. "I've always felt (it was) unfair that my brothers had higher education. I wanted to study more too... Whenever I travelled, I refused to call myself a 'housewife'. I always filled in 'housemaker' when the immigration cards asked for my occupation... It sounded more professional."

The desire for higher education and a career became stronger after her daughter moved to the United States in 1991 and got married five years later. "I felt lonely," she said. So in February 2012, at the age of 59, the grandmother of one studied for a Diploma in Business Management at the Management Development Institute of Singapore, and landed her first job two years ago.

To prepare for her diploma, she also took classes in 2008 at two private schools. "Statistics and business law were so difficult. I got through with the help of my husband, classmates and teachers," she said.

Mrs Manzur added: "I remember my first day at work. I was so happy and nervous. Happy because I'd wanted a career for so long; nervous because I wasn't
